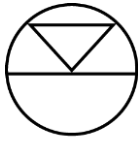

TRADE TERMS & CONDITIONS: FREE UPGRADE WITH INTEGRATED SPEAKERS OFFER

1. This offer runs from 27th June 2016 to 15th August 2016 inclusive. Only orders placed during this period will qualify.
2. Orders must be placed for delivery no later than 31st August 2016.
3. Orders must be placed using the Order Form for this promotion, which must be completed in full.
4. Under this offer, owners of Klimax DS, Klimax DSM, Akurate DS or Akurate DSM can receive a **free upgrade** to the latest specification of their product, featuring Exakt Link connections, when they buy a pair of any of the following speakers or speaker upgrades:
 - a. Speakers
 - Klimax Exakt 350
 - Exakt Akubarik
 - Exakt Akudorik
 - b. Speaker Upgrades
 - Exakt upgrade modules for Klimax or Artikulat 350/350A speakers
 - Exakt upgrade modules for integrated Aktiv Akubarik speakers
5. Owners of Klimax DS and Akurate DS can choose to receive a **half price DS to DSM conversion** instead of the DS upgrade when they buy any of the products listed in point 4.
6. Upgrades to Majik DS, Majik DSM and Majik DS-I are not included in this offer. There is already an ongoing offer for upgrades to these products when purchasing a qualifying product – see the terms of that offer by selecting the relevant product at <http://www.linn.co.uk/hifi-separates/upgrades>.
7. When a customer upgrades or converts their Klimax or Akurate DS/DSM, they have the option to order a Renew DS or Renew DSM as appropriate to re-use their original electronics in a second player. This must be ordered at the same time as the upgrade or conversion.
8. Upgrades can also be ordered without the Renew option, in which case the original electronics will be recycled by Linn and not returned.
9. Only one DS or DSM upgrade can be claimed per Exakt product purchased. There is no limit to the number of Exakt products that can be purchased as part of the offer.
10. Upgrades will be carried out at the Linn factory. Retailers should therefore return the customer's product to Linn using the same shipping process they would use for an RSN. Customer and product details including email address and serial number of the product being upgraded must be provided at the time of order.
11. The upgrade process may involve modification to the metal casing of the customer's original product in order to bring it up to current specification. Retailers must explain this to the customer and by placing the order, the customer gives Linn consent to make any alterations necessary to convert their product to 'current specification'.
12. 'Current specification' is defined by Linn and Linn reserves the right to change that specification in order to perform the conversion or upgrade. Linn agrees to change the customer's product's functionality by fitting the latest specification electronics and parts. However some details of a converted product may differ from brand new stock, for example power switch location and front panel printing.

 - b. Renew products also receive a 5-year warranty from the date of invoice
